### **MAIN PURPOSE OF JOB**

This includes the maintenance activities for the Process network and equipment connected to this network, as well as the maintenance of all process changes as described in Process changes requests.***

### **Key Performance Areas:**

- Ensure that duties are carried out in accordance with safety and quality standards as well as inspection regulations of the Process Plant.
- Ensure a detailed commissioning is done on all changes that are done through the Change Management Program.
- Ensure all documentation for interlock testing is done and signed off.
- Ensure site programming standards are followed and all documentation is up to date.
- Management of changes to be followed and guide all involved to follow the management of change standards.
- Interaction with SCADA operators and metallurgists to ensure good process control standards and quality for system.
- Anti-Virus updates to secure process network, manage all network connectivity to ensure security principles are followed.

- Ensure data accuracy and availability.
- Ensure regular audits are carried out and version control on Rockwell Software.
- Design and construct special apparatus and fixtures and prepare specifications and estimates for construction, repair and installation projects.
