MAIN PURPOSE OF JOB

To support the Environmental Department's performance management through field work activities, using established systems and procedures, by setting and collection of samples, monitoring of baseline information, field observations and recording.

Key Performance Areas:

- **General Duties/Tasks:** Plans and organizes field sampling expeditions; Effectively and systematically manages materials, supplies and equipment; Collects samples, identifies, pack and stores or dispatch samples; Collates information collected and enter into data entry instruments/spreadsheets; Performs rehabilitation activities as needed including the rehabilitation of degraded/disturbed land; Carries out semi-skilled work on a broad range of monitoring equipment; Assists with emergency responses to accidents; Performs lifting and manual handling tasks; Assists periodically with litter clean up on site; Assists with environmental awareness distribution, campaigns, toolbox talks, discussions, creating and installing signage.
- **Sampling and Data Collection:** Learns and performs simple tasks in the monitoring and/or testing of Air Quality, Weather Conditions, Surface and Groundwater, Biodiversity and Radiological samples; Inspect and monitors EMP requirements; Assists with the rehabilitation of disturbed areas.
- **Equipment and Material Maintenance:** Ensure sufficient supplies of sampling materials; Cleaning and maintenance of weather stations and accessories and other sample equipment; Maintain correct and appropriate signage on roads; Keep an inventory/register of equipment, materials and supplies; Report, submit and replace faulty equipment on time.
- **Operations/Project Support:** Provides field assistance; Assists with transportation of donated vegetation; Ensures a biweekly collection of waste to the appropriate skips for disposal, recycling; Provides assistance with the Park roads, linear infrastructure routes and site clean-up of litter; Collates waste management records from various contractors and reports any waste/spillage or non-compliance witnessed.

- Grade 12 with functional math literacy and science or related environmental/physical science qualification.
- Previous experience of field practices, exploration/mining site, environmental an advantage;
