MAIN PURPOSE OF JOB

To monitor and verify that environmental impacts are kept to a minimum during the planning, design, construction and operations stages, and to provide guidance concerning compliance and monitoring with Environmental Management Plans (EMPs), Material Safety Data Sheets (MSDSs), procedures and environmental legislative requirements, codes, regulations standards and Company policies and procedures at all times.

Key Performance Areas:

- **Compliance, Health and Environment Impacts/Permits Effectiveness:** Assist and provides guidance in the development of CEMP/CLEMP compliant Mini EMP's; Implements legislative requirements; Provides identified Material Safety Data Sheet (MSDS) information pertaining to hazardous substances; Implements and enforces the conditions of the CEMP/CLEMP, Mini EMP; Explains Waste Management and Hazardous Materials Disposal systems to Contractors and monitors adherence thereto on a regular basis.
- **Risk Management Compliance:** Implements practices and facilities in respect of health and environment risks; Attends work risk assessments and provides input on environmental risks; Implements environmental technical standards, guidelines, policies and regulations; Assist to prepare compliance audit schedule; Conducts regular scheduled internal site audits and inspections.
- **Environmental Site Monitoring, Inspections, Audits and Reporting Effectiveness:** Arrange access to all designated areas with due regard for health and safety requirements; Undertake daily site inspections to monitor environmental performance and conformance with EMP's and relevant legal conditions; Applies restrictive and control measures from a point of authority invested in allocated areas; Report all environmental incidents; Assist with GIS implementation regarding data upload and map building; Air quality, groundwater and surface water monitoring, weather programmes, biodiversity co-ordination, etc.
- **Environmental Non-Compliance, Corrective/ Preventative Action and Administration:** Issues non-compliance notifications; Compile and provide information for periodic reports; Ensure rehabilitation of areas affected by construction or operational activities; Keep and maintain accurate and detailed reports and registers of all site activities concerning the environment.
- **Environmental Training and Awareness:** Provide continuous awareness of environmental issues to all construction and operations personnel; Support and assist with environmental campaigns or training opportunities.

Requirements and experience:
