## MAIN PURPOSE OF JOB

To assess and execute all identified occupational hygiene stressors through the implementation of the set OH monitoring programme and relevant action management in order to ensure compliance to legal requirements and other relevant international standards.

## Key Performance Areas:

- Occupational Hygiene Exposure Monitoring: Implementation of the annual OH Exposure monitoring schedule provided by the Occupational Hygienist. Be able to perform hazard monitoring such as noise, dust, fumes, gasses, VOC's etc. and collects and dispatch samples for external analysis and liaise with analytical laboratories for analysis and evaluation of the results;
- **Risk Assessments & Inspections:** Participates in site OH Risk Assessments; ensures that the Hierarchy of Control is followed and adhered to; Conducts inspections and identify conditions not complying with Company OH Standards and recommend suitable corrective actions;
- **Confined Space Clearance Services:** Carries out initial evaluation of potentially hazardous areas and prescribe working conditions and protective equipment required; Issue clearance permits and stop the job/persons from entering a confined space if exposure to employees is deemed unacceptable.
- Data Analysis, Report Writing & Administration Effectiveness: Record and update OH Monitoring results; ensure that all procedures are current and filed in the correct manner; prepare annual Similar Exposure Group reports and any other adhoc monitoring and survey reports as required;
- Occupational Hygiene Instrumentation Utilization: Plans and organizes the efficient and effective utilization of OH monitoring instruments; Compiles and maintains an instrument register to ensure calibration and service schedules; Ensures all monitoring equipment and instruments are in good operating condition; Sends damaged instruments away for repairs and external calibration when needed; Reports any irreparable items and provides input to source and procure new equipment whenever necessary;
- **Professional Development & Growth:** Takes responsibility of self/career development by setting and achieving personal goals; Maintains professional and technical knowledge and skills.
- **Co-worker Effectiveness:** Establishes and maintains sound working relationships with co-workers/ team members; Active participation and contribution towards effective working relationships.
