MAIN PURPOSE OF JOB

Assess and execute occupational hygiene activities through the implementation of the Occupational Hygiene programmes and management plan to ensure compliance to legal requirements and other relevant International Standards.

Key Performance Areas:

- Implements the annual OH Exposure monitoring schedule provided by the Occupational Hygienist.
- Performs hazard monitoring such as noise, dust, fumes, gasses, VOC's etc. and collects and dispatch samples for external analysis and liaises with analytical laboratories for analysis and evaluation of the results.
- Participates in site OH Risk Assessments; ensures that the Hierarchy of Control is followed and adhered to;
- Conducts inspections and identifies conditions not complying with Company OH Standards and recommends suitable corrective actions.
- Carries out initial evaluation of potentially hazardous areas and prescribes working conditions and protective equipment required.
- Issues clearance permits and stops the job/persons from entering a confined space if exposure to employees is deemed unacceptable.
- Records and updates OH Monitoring results; ensures that all procedures are current and filed in the correct manner.
- Prepares annual Similar Exposure Group reports and any other ad-hoc monitoring and survey reports as required.
- Plans and organizes the efficient and effective utilization of OH monitoring instruments;
- Compiles and maintains an instrument register to ensure calibration and service schedules.
- Ensures all monitoring equipment and instruments are in good operating condition; Sends damaged instruments away for repairs and external calibration when needed.
- Reports any irreparable items and provides input to source and procure new equipment whenever necessary.
- Complies with SHERQ policies and practices, and adheres to and maintains work area clean and tidy, in accordance with good housekeeping standards.

Requirements and experience:

- Grade 12 with 20 points over 5 subjects with a recognized Certificate in Occupational Hygiene.
- National Diploma or Degree in Occupational Health and Hygiene or similar will be advantageous.
- At least 3 years' Occupational Hygiene experience within the mining (or similar) environment.
- Proper experience in application of occupation hygiene requirements, and conducting baseline assessments.
- Good understanding of risk assessment principles, data collection and processing.
- Basic report writing and good interpersonal skills, document control and record keeping.
