## **MAIN PURPOSE OF JOB**

Responsible for day-shift production activities, coordinate and supervise contractors assigned to the processing plant, conduct daily inspections of service level agreements, exercise quality control over deliverables of contractors and ensure adherence to the company's safety rules and regulations. Assist production teams in executing their daily work to ensure production targets are met.

## **Key Performance Areas:**

- Coordinate all process maintenance and production activities in conjunction with the Production & Maintenance Superintendents and ensure that all tasks are completed according to plan.
- Defines priorities on all activities to be done and follows up to minimize production delays.
- Surveys pebble stockpiles and compiles month-end reports.
- Takes part in all planning activities and ensure that the drafted plan is communicated to all shifts and cleaning contractor to execute duties according to plan.
- Ensures optimum utilization of plant equipment and people through proper planning and follow up.
- Identifies production problem areas and initiates modifications to improve production.
- Conducts daily and monthly inspections according to schedule and ensures compliance, assisting the processing team to close out non-conformance as per audit findings for both NOSA and LRQA.
- Ensures high availability of plant support equipment at all times and liaises with HDV to ensure quick turnaround time on equipment on break-down.
- Ensures contractors perform work activities according to the scope of work and within the required time.
- Reports any deviations from scope of work and ensure it is addressed at the appropriate level.
- Conducts daily inspections, verifies lockout activities and addresses deviations with all concerned.
- Coordinates all planned activities between operations and maintenance and ensures alignment.
- Maintains project schedule by monitoring all project progress, coordinating activities and resolving problems.
- Ensures contractors adhere to all standard operating procedures and addresses any deviations as a matter of urgency.
