To develop and determine applicable standards when performing inspections and tests on all procedures and oversee all testing methods and maintain high standards of quality for all processes.

Key Performance Areas:

- **Coordination with field contractors/subcontractors and Third Party NDT Inspection Company:** Manages contractors and ensures that the End-user Department's requirements or expectations are met.
- **Reviewing Inspection Reports, Testing methodologies and NDT Procedures:** Elaborates and coordinates welding specifications and codes/standards; Liaises with field subcontractors and the Party NDT Inspection Company. Undertakes QA/QC support activities such as Visual Inspection, Pressure Testing and Non-Destructive Testing (NDT) on a range of plant equipment and mining machinery.

- **Coordinate, monitor and track the issuing and close out of non-conformance reports:** Monitors the disposition of all issued non-conformance reports; Prepares non-conformance reports to the Chief Coordinator and assists in developing corrective actions.
- Reviews contractors and subcontractors' Quality control plans.
- Adheres to all laid down SHER and Quality related standards, practices, policies, procedures, rules and regulations as well as statutes.
